FACTS	WHAT DOES RAPITAL CAPITAL DO WITH YOUR PERSONAL INFORMATION?
WHY?	Financial companies choose how they share your personal information. Tribal together with applicable federal law gives consumers the right to limit some but not all sharing. Tribal together with applicable federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and income • Account balances and payment history • Credit history and credit scores
HOW?	All financial companies need to share customers' personal information to run their everyday business. <p>Why can't I limit all sharing?</p>	<p>Tribal along with applicable federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes—information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you
<p>What happens when I limit sharing for an account I hold jointly with someone else?</p>	<p>We don't offer joint accounts</p>

Definitions

<p>Affiliates</p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Our affiliates include financial and nonfinancial companies such as Uncle Warbucks and other affiliates
<p>Nonaffiliates</p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • Nonaffiliates we share with can include service providers, data processors, advertisers, direct mail companies, lead providers and other authorized nonaffiliates.
<p>Joint marketing</p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • Rapital Capital doesn't jointly market.

Other Important Information

Do Not Call Policy. This notice is the Rapital Capital Do Not Call Policy under the Telephone Consumer Protection Act. We do not solicit via telephone numbers listed on the state or federal Do Not Call lists, unless the law allows. Rapital Capital employees receive training on how to document and process telephone marketing choices. Consumers who ask not to receive telephone solicitations from Rapital Capital will be placed on the Rapital Capital Do Not Call list and will not be called in any future campaigns.
